There is the matter of the final bill they keep sending me - I've included it with this letter and I hope you will take care of this for me.

The other issue concerns not only you, but the church in the Fort Worth area. As I'm sure you're aware of, Catholic clergy have been called in to question as relates to alleged abuse, past and present, at the hands of Catholic priests. Seeing all the news reports

_____ is causing me no small amount of consternation and some anxiety. I really want to know what all that can be done is being done to not only prevent more abuse by clergy, but bring to light any past violations by clergy, no matter how remote positions in the church. This problem isn't one that will go away anytime soon. And after hearing the awful rhetoric proffered by church hierarchy during the recent meeting at the Vatican, I hope you decide to take the most proactive stance possible and disclose what needs disclosing. I'm sure I don't really need to tell you what could happen if you had the chance to be above-board and honest with your parishioners and didn't take it, do I? The backlash rippling through not only local Catholics, but across the country has the potential to be enormous (and in some cases, is already happening).

Thank you for your time, and thank you for helping me.

I met yesterday at the Catholic Center with a 12-year-old boy. He had spoken about being abused by Monsignor James Reilly to his Father James Gigliotti, the pastor of St. Mary Goretti, where he grew up and where his parents still live. JG called me last Monday, and I set up the meeting.

He told of staying overnight one time at the rectory when he was in 5th or 6th grade and being fondled and kissed on the mouth by JR. He recalls it very well and looks back on it with anger, but feels that the event did not affect him long-term. He also said that JR paid for his tuition even though his family could have easily afforded to pay it.

He also told me that several months ago he happened to be with several other classmates, men whom he sees very infrequently, when the conversation turned to sexual abuse and two of them said that they had the very same experience with JR.

He did not want any specific outcome. He insists that he does not need counseling, since the event did not affect him. He just wanted us to know to be sure that we do something to prevent this kind of thing happening to others. I assured him that we have policies in place. But we discussed the problem when children or youth are reluctant or unable to tell anyone about abuse.

Since I had spoken to the boy about the mention of sexual abuse, I will call him tomorrow to tell him that there is nothing to pursue in that regard.
