The undersigned, being duly sworn under oath, states as follows:

My name is (108) and I am 50 years old. Beginning at age 11-12, I was sexually molested by Father Jay Janssen while he was a priest at St. Joseph's School in Fort Madison, Iowa. This occurred in the P.E. office, where he used his hand on my penis and manually stimulated me in the church school office to completion. This was my first sexual experience of any type. The sexual molestation of me continued up until my senior year in high school. I attended St. Ambrose University for two years. Father Wiebler came to my dorm room at St. Ambrose University and knocked on the door. He came into my room and pulled my pants down. He told me Father Janssen had told him that I would not mind if he did this to me. I resisted his further sexual advances. I married at age 20 and have divorced. My early marriage, I believe, in part was my wanting to prove to Father Janssen that I was a heterosexual and not interested in any of his ongoing sexual advances.

Father Janssen has asked me to write letters to him. I am aware of at least two investigations by the Diocese into Father Janssen's activities. One time I wrote a letter where I said I was not involved in secret sex clubs with Father Janssen and had not participated in group sex. I never denied sexual contact with Father Janssen in that letter. I also wrote a letter to him supporting his attempt to become the world's oldest life guard while he was attempting to be a life guard at the Davenport

Outing Club. I also did not reveal in that letter that he had sexual contacts with me. At one point, during one of the investigations, he indicated that "two bitches in Davenport are after me".

I made several trips to Sugar Creek when Father Janssen was transferred there. While there, I came to know John Doe I and participated in out of state trips with him. I also knew his brother and took trips with him.

I am also aware of strange activities on the part of Father Gertz from Farmington, Iowa. We visited him at one time at a location in the presence of Father Janssen. While together, Father Gertz had an 8 mm pornographic movie which he played for those present, including Father Janssen.

Father Janssen always promised when he sold a house that he would provide me with savings bonds. When I went through my divorce from my first wife, I needed money and Father Janssen gave me some savings bonds. He was also an invited guest at my wedding, although I wanted to make sure he knew that I was now married and did not want any more sexual advances from him.

I currently have remarried and have ~~two~~ ^{three children and one stepchild.} children. I live in Oklahoma and my motivation for executing this Affidavit is to set the record straight and dispute the denials by Father Janssen that he did not engage in sexual contact with a minor member of the parish.
