Simansky, Archbishop of Tampico, Luis Munive Escobar, Bishop of Tlaxcala; Luis Marín Cantón, Bishop of Tapachula; Arturo Lona, Bishop of Tehuantepec; Héctor González, Bishop of Campeche; Lorenzo Cárdenas Aregullín, Bishop of Papantla; Jesús C.
